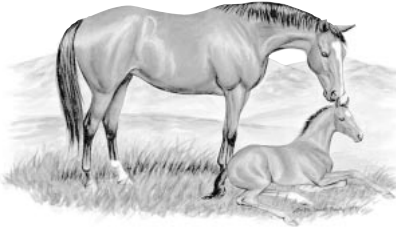

Yearling Nomination for Foals of 2008

Deadline March 31, 2009

WEST VIRGINIA BREEDERS CLASSICS, Ltd. (WVBC) races are restricted to horses that have been nominated to the WVBC. West Virginia Breeders Classic, Ltd. shall give equal consideration to all horses qualifying under the West Virginia Breeders program based solely on the horses' sex, age and earnings. If a horse was sired by an accredited West Virginia sire or foaled in the state of West Virginia, it may be eligible for WVBC nomination. A horse **MUST** be registered with the West Virginia Thoroughbred Breeders Association to be eligible to run in WVBC races.

To be eligible to be registered with the West Virginia Thoroughbred Breeders Association (WVTBA) the breeder must qualify under one of the following: (1) The breeder of the West

Virginia bred foal is a West Virginia resident; (2) The breeder of the West Virginia bred foal is not a West Virginia resident, but keeps his or her breeding stock in West Virginia year round; or (3) The breeder of the West Virginia bred foal is not a West Virginia resident and does not qualify under -2- above, but either the sire of the West Virginia bred foal is a registered West Virginia stallion at the time of cover, or the mare was covered by a registered West Virginia stallion following the birth of the West Virginia bred foal.

There are **NO SUPPLEMENTS** to the WVBC. If the foal is by an accredited West Virginia sire, which is deceased or moved from West Virginia, it is still eligible for the WVBC if timely nomination payments were made.

Five percent (5%) of the purses for each race will be paid to the original yearling nominator. There will be paid 2% to first; 1½% to second; 1% to third; and ½% to fourth in each race.

Yearling Nomination for Foals of 2008

TERMS AND CONDITIONS

1. There are no provisions for supplementary entries to WVBC races. Unless horses are nominated as yearlings to the WVBC program by March 31, 2009 they will not be eligible to be entered in WVBC Races in any subsequent year.
 2. The nomination fee of \$250.00 per horse shall be paid in full at the time of nomination. This fee is to be mailed in an envelope postmarked on or before March 31, 2009. This qualifies the horse to WVBC Races for life.
 3. WVBC reserves the right to postpone or change the conditions of all the WVBC programs without any liability. WVBC programs may be cancelled without written notice and WVBC shall have no liability except to make distribution of funds in the form of purses and awards less administrative expenses.
 4. Special foal nominator awards shall be paid to the signer of this form if any horses listed hereon finish first, second, third or fourth in any WVBC race in any year. These awards are independent of any other West Virginia award program.
 5. In the event that any nominated foal is unable to be entered - or to run - in any race, regardless of the reason or reasons, no refunds will be paid to foal nominators. Foal nominations are made with the express understanding that no assurances with regard to entry in any race, beyond eligibility to the program, are being given.
 6. This agreement is for horses sired by stallions properly nominated to the WVBC program for the 2006 breeding season, including several deceased stallions. And for all horses qualifying under the West Virginia Thoroughbred Program for each stake race, based solely on the horses' sex, age and earnings.
 7. WVBC, Ltd. Reserves the right to limit the number of starters in any WVBC race. If selection of entries is necessary, WVBC, Ltd. shall have sole discretion over the method used. WVBC, Ltd. Also reserves the right to change the distance or course of any race without liability.
 8. WVBC races shall be run in compliance with the racing rules and regulations of the West Virginia Racing Commission. WVBC, Ltd. shall have no liability for the actions of any officials or employees of the track where such races are held or for any matter under the track's control. Purses and award payments shall be made to the owners or lessees recognized as such by the track and the West Virginia Racing Commission.
 9. WVBC, Ltd. Reserves the right to broadcast, televise or record WVBC races and the activities incident to them, and to exploit same by any means. WVBC, Ltd. Also reserves the right to use the names and likenesses of nominated stallions and their progeny in its promotion and advertising in any manner deemed appropriate.
 10. Winners circle ceremony shall include owners, trainers, and breeders.
 11. The nominator grants his consent to be photographed without remuneration and agrees to obtain such consent from his employees, agents and associates when and if required. Nominator further understands and consents that use by him of the name or logo of WVBC shall only be made in accordance with rules established by WVBC, Ltd.
 12. WVBC, Ltd. makes no representations or warranties as to benefits being realized as a result of participation in any WVBC program. WVBC, Ltd. shall not be liable if any benefits anticipated by a nominator are not realized for any reason whatsoever.
 13. Purse distribution for WVBC day races shall be as follows: First 50%, Second 22%, Third 11%, Fourth 7%, Fifth 5%, and Sixth through Tenth 1% each. Any unpaid percentage(s) will be paid to the winner. Ten percent of the day's gross purses will be paid in the form of nominator awards; 5% directly to stallion nominators and 5% directly to foal nominators, as explained in condition 4.
 14. WVBC, Ltd. is a trade association and, accordingly, nominations are not deductible as charitable contributions for federal income tax purposes but may be deductible as business expenses.
