Stallion Nomination

Deadline July 31, 2008

WEST VIRGINIA BREEDERS CLASSICS, Ltd. (WVBC) races are restricted to horses that have been nominated to the WVBC.

West Virginia Breeders Classic, Ltd. shall give equal consideration to all horses qualifying under the West Virginia Breeders Program based solely on the horses' sex, age and earnings.

A horse must be registered with the West Virginia Thoroughbred Breeders Association to be eligible to be nominated to the WVBC.

There are **NO SUPPLEMENTS** to the WVBC.

FIVE PERCENT (5%) OF THE PURSES FOR EACH RACE WILL BE PAID TO THE ORIGINAL STALLION NOMINATOR. There will be paid 2% to first; 1½% to second; 1% to third; and ½% to fourth in each race.

If the foal is by an accredited West Virginia sire which is deceased or moved from West Virginia, it is still eligible for the

WVBC if timely nomination payments were made for the stallion and his offspring conceived while he was standing in West Virginia.

TERMS AND CONDITIONS

1. The nomination fee of \$100.00 for the stallion must be paid at the time of nomination. This fee is to be mailed in an envelope on or before July 31, 2008.
 2. There will be no supplementary nominations. Unless stallions standing in West Virginia in 2008 are nominated by July 31, 2008, neither their foals born in 2008 nor their progeny of previous years will be eligible for nomination.
 3. WVBC Ltd. reserves the right to postpone or change the conditions of all or any part of the WVBC programs without any liability. WVBC programs may be cancelled without notice and WVBC Ltd. shall have no liability except to make the distribution of funds in the form of purses and awards less administrative expenses.
 4. Special stallion nominator awards will be paid to the signer of the stallion nomination form if progeny of any stallion listed on such form which were conceived in West Virginia finish first, second, third or fourth in any WVBC race in any year. The awards are independent of any other West Virginia award program.
 5. In the event that the progeny of any nominated stallion are ineligible for any reason whatsoever to run in WVBC races, no refunds will be paid to stallion nominators. Stallion nominations are made with the express understanding that no assurances with regard to entry of progeny in any WVBC races, beyond eligibility for nomination to the program, are being given.
 6. WVBC races shall be run in compliance with the racing rules and regulations of the West Virginia Racing Commission. WVBC, Ltd. shall have no liability for the actions of any officials or employees of the track where such races are held or for any matter under the track's control. Purses and award payments shall be made to the owners or lessees recognized as such by the track and the West Virginia Racing Commission.
 7. WVBC, Ltd. Reserves the right to broadcast, televise or record WVBC races and the activities incident to them, and to exploit same by any means. WVBC, Ltd. Also reserves the right to use the names and likenesses of nominated stallions and their progeny in its promotion and advertising in any manner deemed appropriate.
 8. The nominator grants his consent to be photographed without remuneration and agrees to obtain such consent from his employees, agents and associates when and if required.
 9. The nominator understands and consents that use by him of the name or logo of WVBC shall only be made in accordance with rules established by WVBC, Ltd.
 10. WVBC, Ltd. makes no presentation or warranties as to benefits being realized as a result of participation in any WVBC program. WVBC, Ltd. shall not be liable if any benefits anticipated by a nominator are not realized for any reason.
 11. Purse distribution for WVBC day races shall be as follows: First 50%, Second 22%, Third 11%, Fourth 7%, Fifth 5%, and Sixth through Tenth 1% each. Ten percent of the day's gross purses will be paid in the form of nominators awards; 5% directly to stallion nominators and 5% directly to foal nominators.
 12. WVBC, Ltd. is a trade association and, accordingly, nomination payments are not deductible as a charitable contribution for federal income tax purposes but may be deductible as a business expense.
